Community Need

Intimate partner violence (also called domestic violence) is a threat to the safety of women and children that affects approximately 1/3 of women in their lifetime. Nearly 1 million female residents of Arizona have been slapped, pushed or shoved by an intimate partner at some point in her lifetime and over 300,000 Arizona women have been raped by an intimate partner in her lifetime. In 2013, 32 shelters located in 13 counties across AZ served a total of 8,916 adults and children.

National Priority Area and Program Performance Goals: Healthy Futures

Improve the health and safety for women and their children who are facing difficult and life-altering decisions due to domestic violence.

Program Activities

The primary objective of the AmeriCorps member is to serve survivors of domestic violence at domestic violence shelters in our community. This service includes attending domestic violence trainings; delivery of an evidence-based, survivor-focused safety planning intervention; and supporting staff and residents in the domestic violence shelter.

Program Impact

One of the most widely recommended and utilized interventions for survivors of domestic violence is safety planning. Abused women’s safety decisions for their families and themselves are not linear and may change over the course of the relationship. The safety process takes time, resources, and involves women’s consideration of complex individual and community factors such as custody of children, social support, access to affordable and safe housing, employment with a living wage, feelings for their partner, confidentiality, and severity of violence. We are implementing an evidence-based safety decision aid in domestic violence shelters throughout Arizona with two key components that generally missing from safety planning. First, the safety decision aid includes an assessment of risk and education about risk and risk factors. Second, it includes a decision aid that assists women in weighing their priorities and identifying the factors that are most important in their safety decisions. This intervention help women to consider complex factors during critical decision-making regarding their abusive relationship. This intervention will assist domestic violence survivors who are facing difficult and life-altering decisions about their relationships in order to improve the health and safety of both survivors and their children.

Mission


Improve access to evidenced-based interventions and services for domestic violence survivors throughout the state of Arizona.

OTHER

Many of our AmeriCorps volunteers are students at Arizona State University. Their AmeriCorps service counts as their internship requirement as they work toward a degree in social work or a related field. We provide education and training to enhance their skills and prepare the next generation of health professionals to deal with domestic violence. Our community volunteers:

- Provide direct services to survivors of domestic violence.
- Implement an evidence-based safety planning intervention with survivors of domestic violence.
- Are supervised by trained MSW-level social workers.
- Assist community partner with essential functions of the domestic violence agency as agreed upon by the AmeriCorps volunteer and site supervisor.
- Maintain positive relationships in the community.
- Document time spent and services provided.
- Complete domestic violence and AmeriCorps training in order to earn certificates in domestic violence intervention.
